

Co-op News

GRE Update: Coal Creek Station & HVDC Line

By the time this newsletter gets to you, Coal Creek Station and the HVDC line may have been sold on May 2nd, 2022, the original closing date agreed upon between GRE and Rainbow and GRE and Nexus Line, LLC. We are closely monitoring the status of the transaction and will provide updated information to keep you all informed of this transaction.

Rates: Cost-of-Service Study

LREC's rate structure is in two parts—energy rate and facility charge. A cost-of-service study has been commissioned to determine whether there is a revenue neutral way for LREC to decrease its rates and increase its facility charge so that the costs are shared in the fairest way possible by our members. LREC, much like many other co-ops in the State of Minnesota, continues to gather data through studies like these to determine the most equitable way to allocate costs amongst its members.

Operation Round Up Funds Awarded to Organizations

Funds were granted to six local organizations throughout Lake Region Electric Cooperative's service area from the Operation Round Up

> Program. A total of \$17,500 was awarded by the Operation Round Up Board of Trustees at the April 11th, 2022 meeting. The total amount awarded since 2007 is \$496,870. The next deadline to submit applications for Operation Round Up is June 15th.

- > \$3,000 to **Dunvilla Shooting** Club to refurbish a cabin used for training
- > \$2,000 to Essentia Health St. Mary's Foundation to integrate reading for children
- > \$3,500 to Home and Away Ministries DBA Ruby's Pantry for food distribution program
- > \$1,000 to Lakes & Prairies **Community Action Partnership** to provide basic home repairs for seniors, disabled persons, and low-income families
- > \$3,000 to North Country Food Bank for mobile pantry program
- ➤ \$5,000 to Welcome House to support home for women in recovery and critical transitions

- If the number you use is in our system, the outage management system is able to automatically recognize who is calling.
 - For planned outages, you can receive a call, email, or postcard.

- It can speed up power restoration if we are able to contact you for more information regarding an outage or service issue.
- You can receive billing reminders and notices.
- ▶ Ensure your capital credit notices and checks are mailed to the correct address when they are retired.
- You can receive notices and other important information on cooperative services and programs.

Why I want to be a LREC Director

LREC has taken care of our family and farm electric needs for years and, more recently, our natural gas needs. I would like to use my trust in LREC and be of service to LREC as it makes decisions to generate energy in ways that are good for our members and our earth.

Vegetation Management Supports Reliable Electricity

One of the primary ways Lake Region Electric Cooperative (LREC) ensures reliable electric service to members is by following a vegetation management plan. The Cooperative uses a proactive, rotational system to control vegetation throughout its heavily wooded service territory. With the current cycle wrapping up, 2023 will mark the start of a new four-year cycle.

Lake Region's vegetation management process includes planned maintenance (including tree pruning or felling), reactive pruning, felling trees, mowing, and herbicide application. The Cooperative maintains an easement of 20 feet (10 feet on either side of the power line) to keep lines free from trees and brush. This helps prevent outages and creates a safer environment for line crews working to restore power.

"Trims are favored for trees outside our easement, while removals are preferred for those within," explains Abraham Nebgen, system arborist at LREC. "Reactive trimming and removal are performed for trees that pose a hazard to overhead line."


Mechanical trimming and mowing are also utilized. In areas with high trimming density, crews deploy a mechanical trimmer in conjunction with a mower. Mowing is used to address areas of high-density small

diameter trees. Herbicide is applied to stumps and used following mowing to help control vegetation.

With all vegetation management measures utilized by LREC, we are committed to keeping our members informed. Mailers, phone calls, and in-person communication

are all used to notify people about work plans affecting their property. Please allow crews to trim what's necessary to keep the power flowing for you and your neighbors.

If you notice a tree interfering with power lines, please notify the Cooperative at (800) 552-7658.
