Inflation and Natural Gas Prices Drive the **Need for Additional Revenue**

With the rate of inflation and high cost of natural gas increasing Great River Energy (GRE) wholesale costs, we are anticipating the need to collect more revenue within the next 12 to 18 months. We anticipate an approximate 6% increase in GRE wholesale costs in 2023, which represents approximately \$1,800,000. It is becoming clear that we will need to pass these higher wholesale costs onto the membership. Your board of directors is evaluating the situation to determine the best plan for generating the additional revenue that is anticipated, and such plan will likely lead to an increase in our general service rates. We do not like rate increases, but when they are necessary, we analyze and determine them in a manner to ensure that LREC can cover all its fixed costs. As mentioned in last month's newsletter, there will be a Demand Side Management (DSM) rate increase effective January 2023.

Any such rate increases necessary to generate additional revenue needed would not be driven by LREC or caused by LREC, but rather they would be driven by natural gas price increases and inflation that hasn't been seen for decades. The landscape affecting rates is changing very rapidly. By staying vigilant and staying on top of the massive changes impacting our world and industry right now, and upon receiving new information from GRE, our team has been planning, budgeting, and doing everything we can to mitigate the impact of potential rate increases.

Your board continues to move forward to reach decisions that are in the best interests of the cooperative. An absolute priority of ours is to make sure we keep this topic and related discussion on the table through newsletters, Facebook, and other forms of communication, so that we can be assured that we have done what we can to properly keep you informed of the decisions that will affect our rates and clearly explain the reasons supporting such decisions.

We have only had one general service rate increase in the last decade. LREC has been proactive in lessening the impacts of things outside of its control to maintain rate stability. This proactive approach remains strongly in place today, so that we may continue to plan in a manner that is in the best interests of our cooperative.

Operation Round Up Funds Awarded to Local Organizations

Funds were granted to five local organizations throughout Lake Region Electric Cooperative's service area from the Operation Round Up Program. A total of \$10,000 was awarded by the Operation Round Up Board of Trustees at the October 10, 2022 meeting. The next deadline to submit applications for Operation Round Up is **March 15**th, 2023.

Electric Heating Sales Tax Exemption

Electricity sold for residential space heating, when used as the primary source of heat, is exempt from Minnesota sales tax for the usage months of November through April. Separately metered off-peak systems are also eliqible for the sales tax exemption.

To qualify, members must complete the Sales Tax Exemption Certificate for Residential form located under the Sales Tax Exemption heading at www.lrec.coop/forms. You only need to fill out the form once and it is in effect until you notify us otherwise.

Businesses, Organizations, and Nonprofits


Any business, organization, or nonprofit that has not recently updated their exemption status should visit **www.lrec.coop/forms** and submit an updated Sales Tax Exemption Certificate for Businesses, Organizations, and Nonprofits.

By enrolling in ChargeWise, you'll be able to receive a rebate for up to \$500 to offset the cost of a level 2 EV charger controlled on an off-peak rate (or get up to \$800 off by purchasing from www.energywisemnstore.com).

Three Reasons to Buy an Electric Vehicle

With new options coming out each year offering extended operating ranges and affordable sticker prices, there has never been a better time to own an electric vehicle. While they still account for a small percentage of new vehicle sales in the U.S., there's a compelling case to be made for consumers to consider a full-electric model as their next mode of transportation.



EVs have better environmental attributes than traditional vehicles (even considering the production and disposal of the battery) because of their higher efficiency, lower energy consumption, and lack of tailpipe emissions. Utilities like LREC and our wholesale power provider, Great River Energy, are producing energy from many renewable sources. Currently, our power comes from more than 25% renewables (including hydro). As the source of electricity gets greener, so does the vehicle.

Economic Savings

EVs are less expensive to own and operate than a traditional gas-powered vehicle over the long-term. While they can sometimes cost more to purchase, the federal government offers consumers a tax credit of up to \$7,500 to put toward the purchase of many new EVs. A typical EV can travel about 43 miles on \$1 worth of electricity. Also, EVs have fewer moving parts to break down which means they're more reliable than their gasoline-powered counterparts.
