ETS WATER HEATER (5.5¢ RATE)	Must be at least 100 gallons, grid enabled, with mixing valve	\$400
PEAK SHAVE WATER HEATER	Must be at least 80 gallons, grid enabled	\$100

ELECTRIC VEHICLE (EV)

CHARGER INSTALLATION	MUST BE A LEVEL 2 CHARGER <i>(limit 1 per account)</i>	Up to \$500

Rebates must be purchased/installed between Jan 1, 2025, and Dec 15, 2025

Request for rebates must be submitted to LREC by December 15, 2025. Once funds have been depleted, rebates will cease for 2025.
